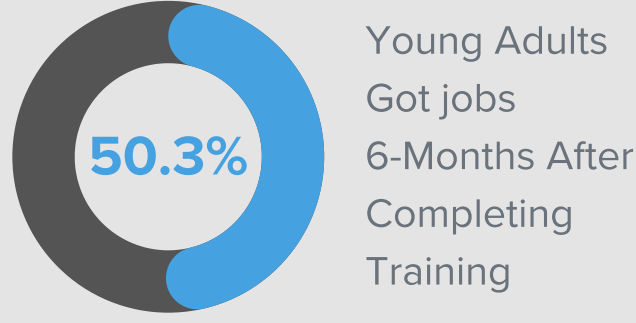

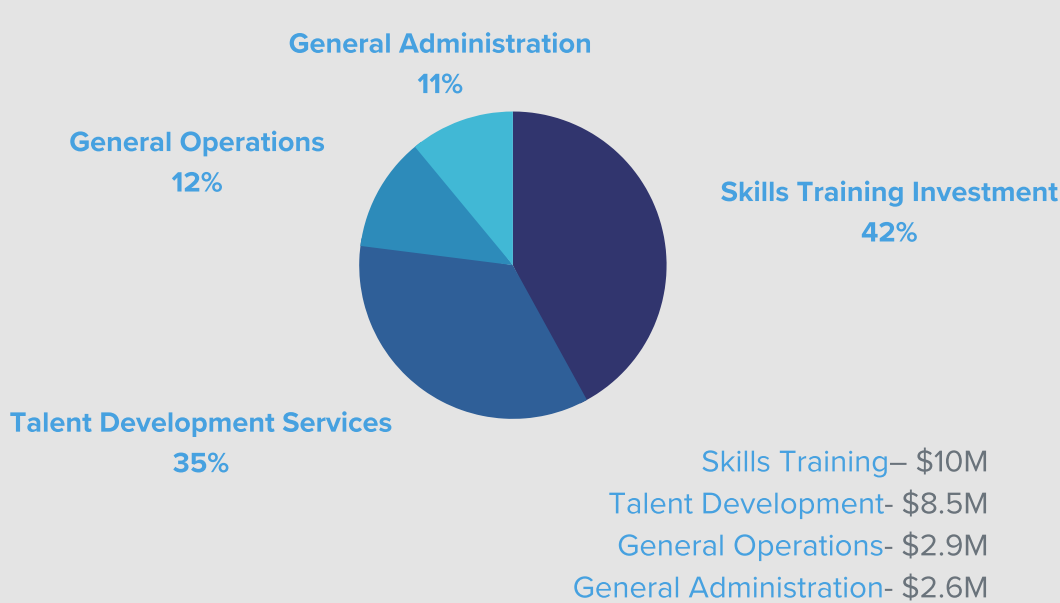

**\$24M** FY 2019-2020 Budget

Typically the CSTB Annual budget ranges between \$20-\$24 million. For the current FY year 2020-2021, with supplemental funding from the CARES Act in partnership with Hillsborough County and National Dislocated Worker Grants through DEO/DOL, the CSTB budget is \$40.1 Million.
